RUSSELL SAGE FOUNDATION Who We Are

"For the improvement of social and living conditions in the United States"
From the Letter of the Gift by Margaret Olivia Sage establishing the Russell Sage Foundation, April 19, 1907

Then (1907-1944)

A source of institutional support, and information for private social agencies on topics like poverty reduction, social work, city planning, labor reform, housing, public health, education, consumer credit, and industrial relations.

Now (1945-Present)

RSF funds basic social science research; strengthening the methods, data, and theoretical core of the social sciences as a means of better documenting and understanding the nation's most pressing social, political and economic problems.

Race, Ethnicity, and Immigration

RSF does not fund:

- Studies focused on health outcomes
- Studies on educational processes, teacher outcomes, or curricular development, etc.
 - RSF considers funding some educational studies on student outcomes
- Studies on subjects outside of the United States of America
- Operational support, program evals, animal studies, etc.



RSF Funding Priorities

Special Initiatives

Immigration and Immigrant Integration (co-funded with Carnegie Corp. of NY)

Promoting Educational Attainment and Economic Mobility among Racially, Ethnically, and Economically Diverse Groups after the 2023 Supreme Court Decision to Ban Race-Conscious College Admission Policies

(co-funded with Hewlett Foundation, Spencer Foundation, and William T. Grant Foundation)



RUSSELL SAGE FOUNDATION Funding Mechanisms

Core Research Grants

Trustee Grants

- \$75k \$200k
- 15% indirect costs
- Approved by RSF Board of Trustees

Presidential Grants

- Up to \$75k*
- No indirect costs
- Approved by president of RSF
- PhD required, no restrictions on nationality or institution
- Up to 2 Year Grant
- 2-stage application: LOI, Proposal

Oct 29 2025; 2 PM ET – REI, BSDMC, SCD23 Mar 11, 2026; 2 PM ET – SPEI & FOW

Sheldon Danziger Pipeline Grants

• 1 Year Grant

\$50k for individuals,\$65k for teams

Competition

- Eligibility: nontenured profs
- Co-funding from the Gates Foundation, The Policy Academies, JPAL

Next Deadline:

Oct 22, 2025; 2 PM ET

Early Career Grants

Causal Research on the Criminal Justice System

- 1 Year Grant
- \$100k max
- Eligibility: tenuretrack asst professors at US institutions
- Co-funding from Arnold Ventures

Next Deadline:

Apr 1, 2026; 2 PM ET

Dissertation Research Grants

- 1 Year Grant
- \$15k max
- Eligibility: ABD PhD students at US institutions
- Co-funding from the W.E.Upjohn Institute and The Policy Academies

Next Deadline:

Feb 3, 2026; 2 PM ET

*Presidential Grants are capped at \$50,000, but PIs may request up to \$75,000 when the proposed research project is a qualitative study, requests access to restricted-use data, or includes salary support for multiple assistant professor PIs.



RUSSELL SAGE FOUNDATION Fellowships and Journal

Visiting Scholars

- Funded residential fellowship (NYC) for applicants 3+ years past PhD during a sabbatical
- Interdisciplinary cohort to strengthen your work before publication
- Deadline in June for residence the academic year that starts 15 months later

Visiting Researchers

- Shorter term stays (up to 1 semester)
- Unfunded but get office, staff support, lunch, etc.
- Deadline in May for residence the following academic year

RSF: The Russell Sage Foundation Journal of the Social Sciences

- Open access, peer reviewed, and interdisciplinary: <u>www.rsfjournal.org</u>
- Topic based issues The Socioeconomic Impacts of Covid-19, Growing up in Rural America,
 Low-Income Families in the 21st Century, Black Reparations, etc.



Core Research Grants LOI Deadline: Oct 29, 2025; 2:00 PM ET

The Research Grant program provides one- or two-year grants of up to \$200,000 for research related to RSF's core program areas and special initiatives.

LOIs are accepted under each program area on a rotating basis across our Spring, Summer, and Fall cycles.

Approval Summer 2026

- Behavioral Science and Decision Making in Context
- Race, Ethnicity, and Immigration
- Immigration and Immigrant Integration
- 2023 Supreme Court Decision to Ban Race-Conscious Admissions

LOI Deadline: Oct 29, 2025

Approval Fall 2026

LOI Deadline: Mar 11, 2026

Approval Spring 2027

LOI Deadline: July 2026



RUSSELL SAGE FOUNDATION Application Materials

Required LOI Materials at Oct 29; 2:00 PM ET


Research Grant Application form via Fluxx* LOI: 4 pages, singled-spaced Abbreviated CV: 5 pages max

The LOI should outline your research's motivation, theory, and contribution. A majority of the space should be dedicated to the research design. References do not count towards the page limit. A 1-page appendix for charts or tables is allowable. Formal budgets **are not** needed at the time of application.

Board or Presidential Approval

Funding decisions for LOIs submitted at the October LOI deadline will be made at the June 2026 Board of Trustees meeting, with an earliest grant start date of September 2026



RUSSELL SAGE FOUNDATION Proposal Materials

If invited to submit a proposal in mid-Jan 2026, applicants then submit:

20-page Proposal

Budget (using RSF Budget Template) Budget Narrative & Project Timeline

LOI Reviewer Response Memo CoPI CV(s), if applicable



Research Grant Application and Review



Funding decisions for LOIs submitted at the October LOI deadline will be made at the June 2026 Board of Trustees meeting, with an earliest grant start date of September 2026.

Sheldon Danziger Pipeline Grants Competition Proposal Deadline: Oct 22, 2025; 2:00 PM ET

The Sheldon Danziger Pipeline Grants Competition provides one-year grants of \$50,000 for early career individual researchers and \$65,000 for research teams related to RSF's core program areas and special initiatives.

Co-funded with The Gates Foundation, The Policy Academies, and JPAL.

Eligibility


- Applicants must be early career scholars (asst prof, lecturers, asst adjunct prof) w/ PhD post Jan 2014
- Not PI/CoPI on past Core RGs
- Associate & full professors may be CoPIs, but are ineligible for funding

Use of Funds/Program Benefits

- No Indirect Costs
- Allowed expenses include: summer salary, data, research assistance, course buyouts, conference travel, etc.
- Senior scholar mentorship
- Workshop conference hosted by RSF

Causal Research on the Criminal Justice System

- 10-page, singlespaced proposal
- CV(s) of PI(s), 5page max

Visiting Scholar & Researcher

• 5-page, single-spaced proposal

• CV of PI

Dissertation Research Grants

- 5-page, singlespaced proposal
- CV of PI, 5-page max

• Budget (template will be emailed to PI)

- Budget Narrative
- (IRB approval, confirmation of data access, etc)

None required
